

Reviaition Industries End User License Agreement

Reviaition Industries User License Agreement By installing from the CD or by opening a vector pack containing Reviaition Industries artwork files, you agree to the terms of Reviaition Industries User License Agreement. This is a contract between you and Reviaition Industries. Please note that this is a license to use Reviaition's vector images and artwork, NOT an agreement of ownership. This license is non-transferable. If you do not agree to the terms, you are not permitted to use Reviaition Industry's Artwork. Please read the terms carefully:

Limited License Upon payment of the non-refundable license fee, Reviaition Industries grants you a non-exclusive, non-transferable, limited right to use Reviaition Industry's vector images for personal or commercial use by you at a single, geographical location (the "Licensed Location"). You may not store Go Media Vector Artwork on a file server that can be accessed via the Internet or other external network system by computers and printers not located at the Licensed Location.

Permitted Copies You may not duplicate or copy Reviaition Industry's vector images and artwork except as needed to use it as expressly permitted by this Agreement. However, you may make one (1) copy of Go Media Vector Artwork for backup purposes. All permitted copies you make must contain the exact copyright, trademark and other proprietary notices that appear on and/or in the Vector artwork including all related documentation.

Intellectual Property Rights You acknowledge and agree that Reviaition Industry's vector images and artwork and permitted copies, and the copyrights associated with Reviaition Industries, are the intellectual property owned by Reviaition Industries. Reviaition Industry's vector images and artwork are protected by copyright including without limitation, by United States Copyright Law, international treaty provisions, and applicable laws in the jurisdiction of use.

You may not copy Reviaition Industry's Artwork except as provided under the "Permitted Copies" provision above.

License Transfer; Service Bureaus You may not rent, lease, sublicense, distribute, lend nor transfer Reviaition Industry's Vector Images and Artwork, or any copy or portion of Reviaition Industry's vector images and artwork, without Reviaition Industry's prior written consent.
